

WindRider International LLC Warranty

WindRider International LLC ("WindRider") warrants that this boat is free from defects in materials and workmanship for a period of two years. WindRider's liability hereunder is limited to repair and/or replacement, at WindRider's sole option, of the boat found to be defective in material or workmanship. This Warranty applies to original owner registered with WindRider International LLC through registration card supplied with boat.

All replacement parts or repairs are covered for a period of two years.

THIS WARRANTY DOES NOT COVER

- • Normal wear and discoloration.
- • Damage caused by abuse or failure to perform normal maintenance.
- • Damage caused by alterations or modifications.
- • Transportation of boat or parts to WindRider, its dealers, or any other destination.
- • Any boat used as a rental or placed in commercial service of any kind.
- • Damage caused by failure to follow procedures in sailing and assembly manuals.
- • Damage caused by mooring or storing boat in water.
- **WARRANTY SERVICE**
- Within 30 days of discovering a defect take your boat, along with proof of purchase (sales receipt or registration card), to the authorized WindRider dealer from whom you purchased your boat, or the WindRider factory. If you have moved or are traveling you may take the boat to the nearest authorized WindRider dealer.
- **LIMITED WARRANTY AND DISCLAIMER**
- EXCEPT AS SPECIFICALLY SET FORTH HEREIN, WINDRIDER MAKES NO EXPRESS OR IMPLIED WARRANTIES, INCLUDING, BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. THE TERMS AND CONDITIONS OF THIS WARRANTY SHALL BE THE SOLE AND EXCLUSIVE REMEDIES OF THE PURCHASER OF THE PRODUCTS MANUFACTURED BY WINDRIDER AND THE PURCHASER SHALL BE ENTITLED TO NO FURTHER OR ADDITIONAL REMEDIES. PURCHASER HEREBY EXPRESSLY WAIVES ANY AND ALL CLAIMS FOR DAMAGES, WHETHER DIRECT, INDIRECT, CONSEQUENTIAL OR INCIDENTAL,

INCLUDING PROPERTY DAMAGE OR PERSONAL INJURY DAMAGE TO THE PURCHASER OR THIRD PARTIES. PURCHASER ASSUMES ALL RISK IN CONNECTION WITH THE OPERATION OF A WINDRIDER BOAT. This Warranty grants specific legal rights, but Purchaser may have other rights that vary from state to state.

This Warranty constitutes the entire warranty and WindRider is not bound by an oral expression or representation made by an agent or party purporting to act for or on behalf of WindRider, or any commitment, arrangement or representation not expressly specified in this Warranty. This Warranty and WindRider's liability hereunder shall be construed pursuant to the laws of the State of Minnesota.

WindRider International LLC strongly recommends that you purchase your WindRider sailboat through your local dealership whenever possible. Due to the unique design aspects and features of our products, your dealer will provide the hands-on service and product assembly to ensure you receive the ultimate satisfaction from your WindRider sailboat. It is important to be aware that WindRider's warranty policy states that any warranty service must be performed by the dealer from whom the boat was purchased, or another service provider approved by WindRider.
